## :Notification:

In exercise of the powers conferred by Regulation No. 26 : ‘*Qualification for appointment.- Age, Experience and other qualifications for appointment to a post under the Institute shall be specified by the appointing authority subject to the condition that non-ayurveda persons shall not be appointed to the post of the Director*’ read with the **Schedule :II** (Power of Authorities of Institute) Authority for Appointment, Confirmation, Promotion and Lien for All posts of Group – B and C has been delegated to Director , ITRA in Institute of Teaching and Research in Ayurveda Regulations, 2021. Accordingly, Director- ITRA hereby makes the following rules regulating the method of recruitment to the below mentioned posts in ITRA:

- Short title and Commencement-** (i) These rules may be called Group-B and C (Non-Teaching-Direct Recruitment Posts) Recruitment Rules of ITRA, 2025.  
(ii) They shall come into force on the date of issuance of notification by the Institute.
- Number of the posts, classification and level in Pay matrix-** The number of said posts, their classification and the level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule annexed to these rules.
- Controlling Authority of the Posts-** The posts shall be controlled by Director, ITRA as per ITRA Regulation, 2021 amended from time to time.
- Method of recruitment, age-limit, qualifications, etc.-** The method of recruitment, age- limit, qualification and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.

5. **Disqualification. No person-**

- (a) Who has entered into or contracted a marriage with person having spouse living, or
- (b) Who having a spouse living, has entered into or contracted a marriage with any person.

Shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. **Power to relax-** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may order and for reasons to be recorded in writing relax any of the provision of these rules with respect to any class or category of persons.


