- The DAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff.
- The DAIP shall have the power to assess the level of plagiarism and recommend penalties accordingly.
- The DAIP after investigation shall submit its report with the recommendation on penalties to be imposed the IAIP within a period of 45 days from the date of receipt of complaint/initiation of the proceedings.
